In order to qualify for Holy Family Parishioner's rate (A), the pastor must verify that a family meets the following criteria:

1. Be registered in Holy Family Parish (all families wishing to be considered for "in parish" rate must be a consistent contributing member for at least 6 months and have a Parish Affiliation Form approved by the parish office.)
2. Attend Mass regularly at Holy Family Parish.
3. Contribute in a consistent manner to support the Parish by means of numbered donation envelopes or Parish Pay for a minimum period of six months. The use of these envelopes is recorded weekly in a confidential manner by the parish staff.
4. Participate in Parish activities.

In-Parish Tuition Assignment Process and Signature Affidavit

In order to receive the discounted “In-Parish” tuition rate, the following requirements must be met:

1. Each year, the registered family must fill out and complete a Parish Affiliation Form. The deadline for returning this form is May 1st.
2. Pastor will verify that the parishioner requirements have been met. They are as follows:
 - Be registered as a parishioner at Holy Family Parish for at least 6 months.
 - Attend Mass regularly at Holy Family Parish.
 - Contribute in a regular and consistent manner to support Holy Family Parish by means of a numbered Sunday Offertory Envelope for a minimum of 6 months.
 - One may also sign up to use our automated giving program called Parish Pay.
 - Participate in Holy Family Parish activities.
3. Once parishioner status is verified and the Parish Affiliation Form is signed and returned by the Pastor, the accounting office will assign “In-Parish” tuition and begin billing in July.
4. If the Pastor deems the registered family ineligible, the family may re-submit a Probationary Tuition Contract and Waiver form.
